#### Before getting in touch

Write us an e-mail or call us, if you or a person you know is threatened by deportation or believes this might soon be the case. You can contact us in any language. Most of us speak English and German and if we do not find a common language and you do not have a translator at hand we will try to organize one.

Before contacting us, please have the following information ready:

- Where do you currently live?
- Do you already have a lawyer?
- Are you already in touch with legal advice services or other supporting groups?
- □ Have you already received a letter with the announcement of your deportation (date, time)?
- □ Where shall you be deported to?

We will first clarify whether we are the appropriate contact for your requests. We will then try to meet you in person, provide you with relevant information or refer you to groups that are suitable to deal with your request.

#### Ways to stop a deportation

Under certain circumstances preventing a deportation is possible. Depending on the situation different measures can be useful to do so. Get in touch with other people affected in order to gain information and to listen to their experiences. **If possible try to discuss your ideas with legal advice services or local supporting groups.** 

The following steps can be useful to prevent a deportation:

- □ Church asylum: Residence on church premises for a certain period of time.
- □ Inability to travel due to physical or psychological reasons.
- □ Marriage to or registered partnership with a person with a German passport or permanent residency status.
- □ Public campaign to raise medial awareness for individual cases.
- $\hfill\square$  Blockades in order to prevent the police carrying out the deportation.
- □ Case of hardship, secondary asylum claim or petition in front of the parliament of the federal state.

In case of individual deportation via plane, before the flight:

• Contact the airline, organize interventions at the airport. Safe your energy until you are inside the plane though as the police is allowed to break your resistance only up to the point you entered the plane.

Inside the plane:

□ Try speaking to the aircraft staff: Shout out loud, refuse to sit down. State that you are not flying voluntarily and ask other passengers to support your resistance. Pilots can refuse to start if it is obvious the person will not fly voluntarily. Find a more detailed guideline on : **nodeportation.antira.info/materialien/** C

### What is a deportation?

Deportation means to be forced to leave a country involuntarily. There are deportations in countries of origin, so called "sichere Drittstaaten" and in countries that are responsible for carrying out the asylum process according to the European Dublin-III-Regulation. As far as we are aware in Germany deportations of individuals, families and collective deportations of groups of people are executed. All of them are carried out by plane, bus or police cars.
